Commissioner Strause called the January10, 2022 Commission Meeting to order at 6:00 PM, followed by the pledge to the flag and a moment of silence.

Commissioner Strause welcomed Heidi Fiedler- Maidencreek Township Commission representative and Josh Steingraber - Ontelauee Township Alternate.

#### **EXECUTIVE SESSION 6 PM-6:18 PM**

**AGENDA:** Commissioner Fiedler made a motion, seconded by Commissioner Hadden to approve the agenda as presented for the meeting.

#### FOR THE RECORD

Commissioner Strause reported since the December 2021 Commission Meeting a Mutual Aid Agreement was signed between Northern Berks Regional Police and Fleetwood Borough Police. This was an allowable administrative decision between both Chiefs for emergency coverage purposes only. Both departments have had to deal with manpower shortages and COVID illnesses.

**Donna Culp, Maidencreek Township** questioned the amount of hours and the possible costs to the taxpayers.

Chief Keiser explained this agreement is for emergency only; we want to avoid assistance by the Pennsylvania State Police.

Harold Wagner, Leesport Borough questioned who (NBRPD or FBP) will take charge of an incident.

Chief Keiser again explained this agreement is for emergency only and where ever the incident occurs the department of that jurisdiction would be in charge. Example: NBRPD would control the scene until FBP could arrive and take control. NBRPD and/or FBP are not the only agencies dealing with manpower shortages and COVID illnesses; Berks DES even experienced mandatory OT due to their manpower shortages.

**Scott Eaken, Maidencreek Township** confirmed a similar Mutual Aid Agreement is in place with Muhlenberg Township Police and Bern Township Police

Chief Keiser confirmed that he was correct. Commissioner Strause again stressed this agreement as well as the others are for emergency purposes only.

**Fred Harrision, Ontelaunee Township** asked who would be responsible should there be a fatal accident and/or a shooting.

**Solicitor Gerber** stressed this agreement is allowable by the Municipal Police Agreement and is in place for emergency purposes only and would allow the departments to have police powers in each other department's jurisdiction.

**COMMISSION MEETING MINUTES:** Commissioner Fiedler made a motion, seconded by Commissioner Strause to approve the December 13, 2021 Commission Meeting minutes as presented. All Commissioners voted, "aye." Motion carried.

**TREASURER'S REPORT:** Commissioner Fiedler made a motion, seconded by Commissioner Hadden to approve the December 2021 Treasurer's report as presented. All Commissioners voted, "aye." Motion carried.

# BUSINESS FROM THE FLOOR None

#### **OLD BUSINESS**

#### **Body Camera – In Car Camera**

Chief Keiser had presented a proposal from Watch Guard/Motorola Solutions during the December Commission meeting for 8 in-car video cameras, 12 body worn cameras, that are cloud hosted and a 5 year service plan in the amount of \$113,625.00. The Chief added an automatic upgrade (refresh) will occur after three years, there is a no fault warranty and this equipment will include license plate readers.

Berks County District Attorney has committed to a contribution towards the purchase. The Chief added he will be preparing policy for the implementation and use of this equipment.

As agreed during the 2022 Budget Workshop; payments towards this equipment purchase would be paid with Thompkins Vist Funds.

James Moquin, Leesport Borough Alternate questioned the maintenance and/replacement should equip break.

Chief Keiser informed everyone a service agreement/replacement is included with the purchase. The Body cameras are the most fragile. Should a camera break a replacement will be provided until the faulty camera can be repaired.

**Commissioner Fiedler** asked if the activity from the body cameras and/or the police vehicle can be viewed remotely.

Chief Keiser stressed for security reasons police activities would not be viewed remotely. Activities recorded on body cameras and/or the police vehicle cameras will be reviewed by a "The Command Staff" (Sergeants and the Chief of Police), only.

Harold Wagner, Leesport Borough was concerned about insurance coverage for the equipment.

Chief Keiser included as he said before; there is an automatic upgrade (refresh) after three years, there is a no fault warranty on this equipment.

Commissioner Strause made a motion, seconded by Commissioner Fiedler approving the purchase of 8 in-car video cameras, 12 body worn cameras with cloud hosted service and a 5 year service plan in the amount of \$113,625.00 through Watch Guard/Motorola Solutions. All Commissioners voted, "aye." Motion carried.

#### **GOOD OF THE ORDER**

**Harold Wagner, Leesport Borough** asked the Commissioners to consider adopting resolution and/or ordinance limiting who may speak during a Police Commission Meeting. He feels people who are not residents/tax payers of the NBRPD jurisdictions should not be allowed to speak.

The Solicitor added that this type of action could be considered a violation of the Sunshine Act. Any member of the public may attend the Commission meeting and watch. There are rules of decorum that should be followed when conducting a public meeting.

Commission Chairman Strause stressed that the Commission is moving forward and will not allow any type of objectionable comments. They will be stopped immediately – this goes for anyone.

#### **ADJOURN**

Commissioner Fiedler made a motion, seconded by Commissioner Hadden to adjourn the meeting at 6:53 PM. All commissioners voted, "aye." Motion carried.
