<u>**OLD BUSINESS:**</u> Fleet <u>Update</u> – Officer Dillman reported that he will be meeting with a County Detective and a representative from First Response (our previous upfitter) on June 10 to receive our property and funds.

NEW BUSINESS:

LPR's – Consider Proposal for Platelogiq – Chief Keiser said that he distributed the PlateLogiq/VIPR proposal to the commissioners. After speaking with the District Attorney's office, they have agreed to fund 2 of the 4 requested LPR locations for 2 years. NBRPD would be responsible to pay the remaining 3 years. NBRPD would still like all 4 intersections to have LPR's. If we accept the DA's offer, they would pay \$19,300/year for 2 years. This would leave NBRPD responsible for \$2,400/year for cell service and \$17,000/year for the first 2 years. NBRPD would then be responsible for a total amount of \$36,300/ year for the final 3 years and the \$2,400/year cell service fee. Chief Keiser stressed that the benefits of the LPR's far outweigh the costs.

Commissioner Meck said that if we have any "leftover" budgetary funds at the end of 2025, we should use those to cover this project, rather than returning them to the municipalities as we have done in years past. Alternate Franke asked for a timeline for project completion and Chief Keiser said it should be done in a month. Commissioner Grebloski made a motion, seconded by Commissioner Strause to accept the proposal from Platelogiq. All commissioners voted, "Aye". Motion carried.

New Vehicle – Consider motion to purchase 2025 Police Interceptor Utility vehicle not to exceed \$50,000 (up-fitting and graphic costs to be approved at a later date) – Officer Dillman would like a new vehicle purchased to replace Car #4, which would be kept in the fleet and be utilized as the primary vehicle for shifts at the Schuylkill Valley School District. Commissioner Meck asked if this is in the budget. Officer Dillman said we already purchased the vehicles that were in the 2025 budget. However, we have been selling our out of service vehicles and should have enough to purchase another new vehicle. Commissioner Grebloski made a motion, seconded by Commissioner Strause to approve the purchase of a new vehicle based on Alysia Fredericks' confirmation of funds via email to all commissioners upon her return to work. All commissioners voted, "Aye". Motion carried.
