We acquired 7 in car camera systems for \$300 on Municibid, which was a huge cost savings to the department. Last week, we received our 2 new AED's. TRAFFIC/SPEED ENFORCEMENT – Speed enforcement is a priority on 61. We also have another aggressive driving enforcement planned. COMMUNITY – We attended Leesport Area Community Days. PERSONNEL/DEPARTMENT NEWS – Officers are filling all available overtime shifts and assignments. RECOGNITION – 4 of our officers were recognized by Kutztown University PD for assisting during a recent incident/investigation.

Commissioner Grebloski asked if the drug arrests were felony arrests. Det. Sgt. Wood said that they were not felony arrests. Det. Sgt. Wood also briefly discussed the mutual aid incident with Kutztown. This involved a lot of hours in Maidencreek Township and this incident resulted in an incarceration.
