Chief Keiser then went over some things of note for the month of November. He said that we received 3 applications for police officer. He stated that Officer Venegas is now qualified as a firearms instructor and will be able to work with Officer Dillman on firearms training and qualifications. Chief Keiser reported that Sgt. Showalter will be out for the rest of 2025, with hopes to return in early 2026. The department has really stepped up to cover these available OT slots. Performance evaluations have all been completed.

**BUSINESS FROM THE FLOOR:** Donna Culp wished everyone a safe and happy holiday season.

**OLD BUSINESS:**

Distribute 2026 Draft Budget and Consider Motion to Approve 2026 budget – **Commissioner Strause** made a motion, seconded by **Commissioner Meck** to approve the 2026 budget. All commissioners voted, “Aye”. Motion carried.

Update on Department Holiday Dinner – Alysia Fredericks mentioned that we would need to postpone the holiday dinner as too many officers are unable to attend an event in December.

**NEW BUSINESS:**

Reorganization meeting to be held on Monday, January 12, 2026 at 6PM immediately followed by the regular police commission meeting. Consider motion to authorize the advertisement of all 2026 meetings – **Commissioner Meck** made a motion, seconded by **Commissioner Grebloski** to authorize the advertisement of the January 12<sup>th</sup> meeting. All commissioners voted, “Aye”. Motion carried.

Right to Know Law Appeal of C. Panneton – Authorize Kozloff Stoudt, P.C. to Defend the Appeal – Commissioner MacFarlane stated that Mr. Panneton withdrew his appeal so this authorization is no longer necessary. However, Mr. Panneton did submit a second Right to Know request that we will be working on, which may result in another appeal.

Long Barrell – Distribute Compiled Financial Statements and Agreed Upon Procedures reports for the year ending 2024 to the commission – **Commissioner Meck** made a motion, seconded by **Commissioner Strause** to accept the financial reports prepared by Long Barrell. All commissioners voted, “Aye”. Motion carried.

**FOR THE GOOD OF THE ORDER:**

**Solicitor Macfarlane** recommended that we amend the agenda to include the authorization of advertising all of the 2026 police commission meetings. **Commissioner Meck** made a motion, seconded by **Commissioner Strause** to amend the agenda to include “Consider motion to authorize the advertisement of all 2026 meetings.” All commissioners voted, “Aye”. Motion carried.

**Commissioner Meck** made a motion, seconded by **Commissioner Strause** to authorize Alysia to advertise all of the 2026 meetings. All commissioners voted, “Aye”. Motion carried.
