RESOLUTION 1-2026

Resolution 1-2026 is a Resolution to Set Officers' Pension Contribution. It reads as follows "BE IT AND IT IS HEREBY RESOLVED, by the Northern Berks Regional Police Commission THAT:

WHEREAS, in accordance with the provisions of Act 600 of May 29, 1956, a pension plan administrator may, on an annual basis, by ordinance or resolution, reduce or eliminate payments into the Police Pension Fund by members; and

WHEREUPON, it has been resolved and is hereby resolved that the member contributions to the Northern Berks Regional Police Pension Plan will be set at 2.5% of compensation for the period from January 1, 2026 through December 31, 2026 in accordance with Article 24 of the Northern Berks Regional Police Collective Bargaining Agreement and Article VI, Section 6.2 of the Northern Berks Regional Police Pension Plan Document.

Commissioner Meck made a motion, seconded by **Commissioner Grebloski** to adopt Resolution 1-2026. All commissioners voted, "Aye". Motion carried.
